WHAT WILL MY PAYMENTS BE?

Your payment is calculated by the type of structure, cost of the unit, the length of term you select and the amount you pay up front.

WHAT HAPPENS TO MY DEPOSIT?

The deposit can be applied to your Early Payoff Option for accounts in good standing and with fewer than three late payments.

WHEN DO I BEGIN MAKING PAYMENTS?

After delivery, our Welcome Center will call you with account details and setup your payment due date at that time. Choose between making full payment once a month or breaking payment in half for twice a month payments, whichever fits your budget best!

HOW MUCH IS DUE TODAY?

The first month's rental payment and a security deposit (if applicable).

HOW MUCH INTEREST IS CHARGED?

Rent to Own does not apply interest, but rather a portion of your payment goes toward the balance of the unit and a portion of the rental fee.

MAY I PAY OFF EARLY WITHOUT PENALTY?

Absolutely! In fact, an early payoff will save you money on remaining rental payments! Contact our customer service representatives to receive an Early Payoff Option quote at any time.

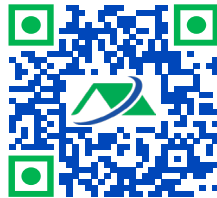

WHAT IS A LIABILITY DAMAGE WAIVER ?

A Liability Damage Waiver is available for purchase on all Rent to Own leases. LDWs protect your leased property from Theft, Natural Disasters such as lightning, fire, high wind or earthquakes, and GAP coverage if your rented unit is insured, but your insurer pays you less than you owe for the rented unit. To purchase a Liability Damage Waiver for your unit, contact a Customer Service Representative. Mower and tractor leases will receive a reduced deposit when signing up for a LDW.

CONTRACT LENGTHS

24 MONTH

You will gain ownership in two years!
All units eligible.

36 MONTH

You will gain ownership in three years!
All units eligible.

48 MONTH

You will gain ownership in four years!
Select units eligible.

60 MONTH

You will gain ownership in five years!
Select units eligible.

72 MONTH

You will gain ownership in six years!
Select units eligible.
